Diploma of Outdoor Leadership



The SIS50419 Diploma of Outdoor Leadership reflects the role of highly skilled senior leaders or program, logistics and operations managers. Senior leaders lead and supervise dependent participants in recreational activities and have a role in planning these activities. They are highly proficient in activity techniques and have well-developed leadership skills to manage group participation, cohesion, operational logistics, risk and significant problems as they arise.

Managers are involved in recreational program planning, implementation and evaluation, facility and equipment management, the leadership of personnel, and the operational management of a department or a small business. All work with significant autonomy, using initiative and judgement to analyse and solve complex problems, and to design systematic approaches to operational practices.

This qualification provides pathway to work for any type of organisation that delivers outdoor recreation activities including commercial, not-for-profit and government organisations.

Typical learning pathways

There is no defined learning pathway in Scouts Australia that provides all of the learning and experiences that align to the requirements of the Diploma of Outdoor Recreation.

• Following Scout learning pathways it is highly recommended that participants initially complete the Certificate IV in Outdoor Leadership which typically results in being 60% - 75% complete against the Diploma of Outdoor Leadership.



Members of Scouts Australia do not incur additional costs to complete a qualification. Anyone who has sufficient evidence can apply for a Recognition of Prior Learning (RPL) assessment.

Diploma of Outdoor Leadership (SIS50419)

A range of experiences and outcomes from Scouting and elsewhere in your life may contribute evidence towards the Diploma of Outdoor Leadership.

- Applying your outdoor adventurous skills and knowledge on additional camps, workshops, trips and adventurous journeys will embed your learning.
- To further develop your leadership of adventurous activities, work with a broad range of appointed Guides or Instructors to conduct outdoor activities.
- Maintain a logbook as you participate in events and trips using your outdoor adventurous activities skills.
- Complete the Wood Badge training Scouting Leadership
- The additional modules for the Scouts Australia 'Axe and Log' will also be beneficial:
 - Scouting Proficiency Fundamentals
 - Scouting Proficiency Programming
- Undertake a role providing leadership to adventurous activity teams, example Region or Branch Activities Commissioner.

Structure of the Qualification

The Diploma of Outdoor Leadership requires 28 units of competency:

- 13 core units
- 15 elective units, consisting of:
 - all the units in any two activity groups (Groups A to AE)
 - the remaining elective units can be selected from the listed electives or from any other current training package or accredited course.

The tables below assume that you have followed the recommended Scouting pathway and previously completed the Certificate IV in Outdoor Leadership.

Assessment

After enrolling you will;

- 1. Need to provide copies of the evidence that you are using for your RPL assessment.
- 2. After evidence is provided an Assessor will be assigned who will assess your evidence and work with you to address any gaps against the requirements of the qualification.

If you need assistance to decide what units of competency to include, discuss what you would like to achieve and what evidence you have with your Branch Commissioner for Vocational Education and Training (VET).

Evidence which may be requested

Your Assessor will need to be able to view your portfolio of evidence either physically or preferably a scanned copy.

- Logbook of outdoor adventurous activities
- Photos, videos from activities
- Adventurous activities work books
- Letter of recommendation or reference
- Copies of existing qualifications
- Providing a copy of your Resume or Curriculum Vitae is usually very beneficial.
- RPL Assessment Tool Kit. If required this will be provided by your Branch Commissioner for Vocational Education and Training (VET) or your Assessor

Upon successfully completing your assessment, you will receive a SIS50419 Diploma of Outdoor Leadership with a transcript listing the units of competency you have completed.
